Subject: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Intimation regarding receipt of insurance claim for loss of capital assets.

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that a fire incident had occurred at the company's erstwhile central warehouse located at J.L No. 11, Prospace Industrial Parks, Mouza − Belumilki, Pearapur Gram Panchayat, Sreerampur District, Hooghly − 712 223 West Bengal, on May 20, 2024 and was previously disclosed in the Red Herring Prospectus/Prospectus. This incident resulting in a significant loss of inventory valued at ₹50.85 crores and capital assets valued at ₹4.24 crores.

Further, the Company has received an amount of ₹3.48 crores, including salvage value against a total capital assets loss of ₹4.24 crores under the policy number OG-24-2495-4008-00000005 of Bajaj Allianz General Insurance Co. Limited. The claim for the inventory loss is still under review and will be settled separately in due course.

The detailed disclosures as required under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed as **Annexure I**.
